# Refinancing of NMFA Loan Resolution

The refunding of our current loan and additional funds of \$50,000 was approved by NM Finance Authority on November 19<sup>th</sup>.

- o Original Loan amount \$427,511
- o Principal of refunding is \$106,196 - New Loan amount \$156,196
- o Loan Extended by 5 years to 2030
- o Net interest will be 1.57% and coverage will be at 2.33x (required is (1.30x)
- o No debt service since loan is under \$250,000
- o The District will achieve \$4,200 in savings over the life of the refunding
- o Previous payment \$27,794/year \$2316.16/month
- o New payment \$17,311/year \$1442.58/month

- o \$873.58 savings per month!
- o The additional funds are scheduled to be utilized for:
  - HVAC Unit for Administrative side of building (needed ASAP) \$12,000
  - Luxury Tile for the kitchen, hallway, and bathrooms \$8,000
  - Security Gate w/ keypad \$10,000
  - Resurface and restriping our parking lot \$15,000
